



FOOD SAFETY TRAINING

Whether you are new to food safety concepts, would like to learn more about how the Food Safety Modernization Act (FSMA) will impact you, or are thinking about having a third party audit, this introductory training will help you assess your understanding of food safety.

FOOD SAFETY IS GOOD BUSINESS

You will leave the training with a basic understanding of what food safety Good Agricultural Practices (GAP) look like on a farm, and next steps for your own farm. The workshop will also ready you for Tier 2 and Tier 3 training where you create a custom food safety plan for your farm, and prepare for a third party audit or produce safety rule compliance. Trainings are conducted by local specialists and extension agents.

MEET THE INSTRUCTORS

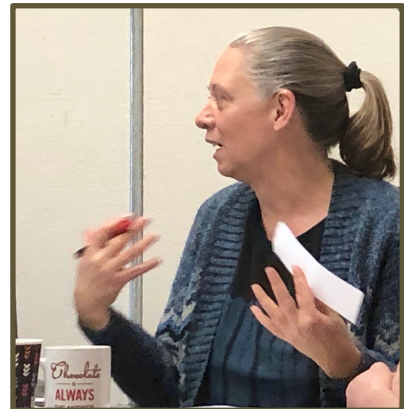
John Garlisch **Agriculture Agent, New Mexico State University**
