New Mexico Grown provides opportunities for local producers to sell to schools, senior centers, early childhood centers, and food banks. Allowable food products currently include produce, nuts, grains, legumes, and meat, including minimally processed foods.

The **Approved Supplier Program** is THE entry point for local producers to sell their products to New Mexico Grown buyers. ALL New Mexico Grown purchases must be from Approved Suppliers. **IT'S EASY TO GET STARTED!**

PRODUCE-PLUS

If you would like to sell produce, nut, grain, or legume products, choose one:

- FY24 New Individual Vendor Application English or Spanish
- FY24 Returning Individual Vendor Application English or Spanish
- Food Hub / Distributor Application English or Spanish

Deadlines for Produce-Plus applications for fiscal year '24 (July 1, 2023- June 30, 2024) are:

- March 31, 2023: Vendors who submit their application by March 31, 2023, will be approved for sales to schools and other institutions by July 1, 2023.
- Rolling approval after March 31, 2023 will be done on a case-by-case basis. Approval may take up to 45 days.

MEAT

If you would like to sell meat products including beef, bison, lamb/mutton, or pork:

• FY23 Meat Vendor Application is still open • FY24 meat applications will be released by May 1, 2023, with a priority deadline of May 31 and rolling approval after that.
