For purposes of this Agreement, "resale" is defined as the purchase of agricultural products by market vendors for resale to market customers.

SALE OF ANY GENETICALLY MODIFIED FOOD OR FOOD INGREDIENT IS STRICTLY PROHIBITED.

By signing this agreement/registration, you also agree that the Market manager or a representative designated by Market management may, upon reasonable notice, inspect your fields, orchards, and/or hives, storage buildings, and outbuildings at any time during the market season. Market management and the vendor may agree upon an independent third party or parties to conduct any such inspection.
